RESOLUTION NO. 90.

"WHEREAS, when the former telephone system in Ormoc City stopped operations the company left its wires still attached to the poles of the Ormoc Electric Company;

"WHEREAS, the company has since then abandoned the maintenance and upkeep of these telephone wires; and

"WHEREAS, these telephone wires are hanging low over the streets all over the city and as such causes much hindrance and obstruction to the free flow of traffic;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Guillermo T. Parrilla;

"BE IT RESOLVED, as it is hereby resolved, to declare these telephone wires which are now hanging low over the streets in the city, a nuisance;


"BE IT RESOLVED FURTHER, to request the Manager, Ormoc Electric Company, to cause to be removed from their electric posts these telephone wires on or before the 31st day of May, 1957;

"BE IT RESOLVED STILL FURTHERMORE, to inform the owner of these telephone wires that should they not be removed after May 31, 1957, the city government will undertake to remove these wires at the expense of the owner; and


"BE IT RESOLVED FINALLY, to furnish copies of this Resolution each the Manager, Ormoc Electric Company, His Honor, the City Mayor, the City Engineer, the Chief of Police, the Fire Chief, and a copy posted at the door of the former telephone system's office, all of Ormoc City.

"CARRIED UNANIMOUSLY."


