RESOLUTION NO. 93

"WHEREAS, Lots Nos. 37, 610, 827 and 879 of the Cadastral Survey of Ormoc have been reserved as City Hall site by this Board in several resolutions passed and approved since 1948;

"WHEREAS, the same lots mentioned above have been declared public land by the Court of First Instance of Leyte and therefore, is not yet a property of the city;

"WHEREAS, in its plans to improve the city in the interest of the public in general, the Municipal Board desires that the lots mentioned above be owned by the city government of Ormoc;


"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to request the City Attorney, Ormoc City, to file the necessary petition in court so that the City of Ormoc be issued Certificate of Titles or any papers showing ownership of the lots mentioned above, for the purpose already contemplated in previous resolutions of this Board;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the City Attorney, Ormoc City; His Honor, the City Mayor, the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.

"CARRIED UNANIMOUSLY."


