RESOLUTION NO. 85

"WHEREAS, in the fiscal budget of Ormoc City for 1956-57, there are incorporated fourteen classroom teachers for the Ormoc City High School, two of these positions new for said fiscal year;

"WHEREAS, one of these two new positions was filled in by Mrs. Otilia F. Devaras from June 18, 1956 to October 31, 1956, having rendered services for this entire period;

"WHEREAS, from the date of its submittal to the Department of Finance for approval, said budget for the fiscal year 1956-57 has not been approved until this date; and

"WHEREAS, because of this non-approval of said budget Mrs. Devaras had not been paid of her salary for services rendered during the period mentioned above; and

"WHEREAS, considering that this is an obligation of the city government which is rightfully due Mrs. Devaras;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to appropriate from out of the tuition fees collected from the students of the Ormoc City High School, the amount of ₱665.00, to be made available for the payment of the salary of Mrs. Otilia F. Devaras from June 18, 1956, to October 31, 1956, as classroom teacher of said school;

"RESOLVED FINALLY, to furnish copies of this Resolution each the Division Superintendent of Schools, Tacloban; the Principal, Ormoc City High School, Ormoc City; His Honor, the City Mayor, the City Treasurer, the City Auditor and Mrs. Otilia F. Devaras, all of Ormoc City.
