RESOLUTION NO. 96

"WHEREAS, by virtue of Resolution No. 93, series of 1953 adopting the budget of Ormoc City for the fiscal year 1953-54, carrying salary increases of intermediate school teachers, the Division Superintendent of Schools issued appointments to the teachers affected by said salary adjustment;

"WHEREAS, one of the intermediate teachers whose salary was adjusted by virtue of said Resolution No. 93, s. 1953, is Miss Basilides Ascaño, who filed a request with this Board for the payment of her salary difference amounting to ₱160 corresponding to the period from October 1, 1953 to May 31, 1954, inclusive, at ₱20.00 per month;

"WHEREAS, in view of the representations made by Miss Ascaño requesting payment of <sup>her</sup> salary difference in order to help defray her expenses in attending summer classes in Cebu City, and considering the fact that this is an obligation of the City to Miss Ascaño;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of ₱160.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the payment of the salary difference of Miss Basilides Ascaño;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.
