RESOLUTION NO. 97

"WHEREAS, with the widening of city streets, particularly San Agustin St., Ormoc City, a portion of Lot No. 1229 owned by the late Pelagio Brazil, was used and occupied by the city for the improvement of said street;

"WHEREAS, Mrs. Maria Torrente Vda. de Brazil, administrator of Pelagio Brazil, is making representations with this Board, seeking payment of said portion of Lot No. 1229 used by the city in the widening of San Agustin St., which consists of 15 square meters; and

"WHEREAS, the Committee on Appraisal, Ormoc City, appraised the land mentioned above at ₱10.00 per square meter; and

"WHEREAS, considering that Mrs. Maria T. Vda de Brazil is rightfully entitled to receive payment for her property used by the city;


"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Emilio C. Penserga;

"CARRIED UNANIMOUSLY."


