RESOLUTION NO. 102

"WHEREAS, the Asst. City Health Officer, Ormoc City, transmitted to this Body a first indorsement from the Executive Officer, Bureau of Health, Manila, answering a query from the City Health Officer of Ormoc City, as to whether the donation of a portion of the cemetery site to the Bureau of Telecommunications, subject matter of Resolution No. 8, current series, of this Board, is allowed;

"WHEREAS, in said first indorsement from the Bureau of Health, mention is made of Sections 1075 and 1074 of the Revised Administrative Code, which, according to the same indorsement, would be violated by the occupancy of personnel of a building constructed within a perimeter of 25 meters from the cemetery; and

"WHEREAS, in truth and in fact, the portion of the cemetery site donated to the Bureau of Telecommunications per Resolution No. 8, c.s. of this Board, is more than 25 meters away from the enclosed portion of the cemetery utilized as burying grounds;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to inform the Director of Health, Manila, that the portion of the cemetery site donated to the Bureau of Telecommunications per Resolution No. 8, c.s. of this Board, is more than 25 meters away from the enclosed portion of the cemetery utilized as burying grounds;

"BE IT FURTHER RESOLVED, to transmit the information to the Director of Health, Manila, that the portion donated to the Bureau of Telecommunications will be used by said bureau to construct a power house where no office nor living quarters will be installed because the message center is in the poblacion;

"BE IT RESOLVED FINALLY, to furnish copies of this Resolution each to the Director of Health, Manila; the Honorable City Mayor, the City Health Officer and the City Engineer, all of Ormoc City.


"CARRIED UNANIMOUSLY."




