RESOLUTION NO. 104

"WHEREAS, it has come to the attention of this Board through the June 7 issue of the Manila Times that His Excellency, President Carlos P. Garcia is ordering the acquisition of 100 fire engines under the Japanese reparations agreement for distribution to the provinces

"WHEREAS, Ormoc is one city badly in need of fire engines and fire fighting apparatus to help prevent the repetition of uncontrolled conflagrations such as had happened in 1952 and 1954 where property worth thousands of pesos went up in smoke;


"NOW, THEREFORE, the Board on motion of Councilor Emilio C. Penserga, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to request His Excellency, President Carlos P. Garcia and Civil Defense Administrator Alfredo G. Eugenio, to allocate for Ormoc City three (3) fire engines and/or three (3) units of fire fighting equipments from out of the Japanese reparations which the Philippines will receive this year;



"CARRIED UNANIMOUSLY."


