RESOLUTION NO. 106

"WHEREAS, in a series of indorsements relative to the objections of former Assistant Civil Engineer Adventor Fernandez of Ormoc City to Ordinance No. XIII, Series 1956 of the Municipal Board, Ormoc City, the Director of Public Works and the Honorable Secretary of Public Works and Communications recommended the amendment of said Ordinance No. XIII, s. 1956;

"WHEREAS, this Board acting on the request of the aforementioned Public Works Officials, passed Resolution No. 105 adopting Ordinance No. 2 "An Ordinance further amending Ordinance No. 2, series of 1950, as amended by Ordinance Nos. XII & XIII, both series of 1956", on the same date this Resolution was passed; and

"WHEREAS, this Board in passing said Resolution-Ordinance took into consideration the provisions of Section 23, RA 544 which enumerates the kinds of structures (structures intended for public gatherings or assembly such as theaters, cinematographs, stadia, churches) to be under the responsible charge of of a registered civil engineer, in order to protect the livelihood and profession of licensed architects, engineers and contractors who have been prejudiced by the passage of Ordinance No. XIII, s. 1956 of this Board.

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Jorge P. Tan, Jr.;

"BE IT RESOLVED, as it is hereby resolved, to inform as this Body hereby respectfully informs the Honorable Executive Secretary, Hon. Enrique C. Quema that buildings intended for public gatherings as enumerated in Sec. 23, RA 544, are excluded and that plans and specifications thereof should only be prepared and signed by licensed architects or civil engineers.

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable Executive Secretary, Hon. Enrique C. Quema, Malacañang, Manila; the Honorable City Mayor and the City Engineer, all of Ormoc City.


