RESOLUTION NO. 108

"WHEREAS, Councilor Samson manifested before this Board, in the presence of the Parish Priest of Ormoc City, Rev. Fr. Federico Copuaco, his idea of transferring the City Festival of Ormoc from June 29 to the fourth Sunday of May every year, effective 1958;

"WHEREAS, Councilor Samson, in seeking for the transfer of the City Festival to May instead of June, also manifested that in the past he had observed that the religious side of the fiesta is neglected because the people are inclined to attend social activities;

"WHEREAS, this move to transfer the date of the City Festival will also avoid competition between religious and social activities, because while social festivities will be held on the fourth Sunday of May, the religious side of it will be on June 29th;

"NOW, THEREFORE, the Board, on motion of Councilor Cesar Samson, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to transfer the City Festival from June 29 to the fourth Sunday of May, every year from and starting the year 1958;

"RESOLVED FINALLY, to furnish copies of this Resolution each to His Honor, the City Mayor, Ormoc City; Rev. Fr. Federico Copuaco, Parish Priest, Ormoc City; and copies to be posted at conspicuous public places, Ormoc City.
