RESOLUTION NO. 109

"WHEREAS, this Board passed Resolution No. 46, current series, appropriating the unappropriated balance in the Road and Bridge Fund in the amount of ₱12,942.53 for the collection and disposal of city garbage;

"WHEREAS, the City Engineer voiced his objections to the passage of Resolution No. 46, c.s., saying that the Roads and Bridge Fund can not be appropriated for any other purpose than the maintenance and improvement of city roads and bridges, and recommending further that said amount be reverted and made part of the counterpart fund for the fiscal year 1956-57;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo P. Ocubillo;


"BE IT RESOLVED, as it is hereby resolved, to recall Resolution No. 46, current series;

"CARRIED UNANIMOUSLY."


