RESOLUTION NO. 110

"WHEREAS, this Board has been reliably informed that Mr. Leonardo L. Torredes, District Supervisor, District I, Ormoc City is contemplating to close the primary school in Alegria;

"WHEREAS, the closing of said primary school in Alegria would greatly prejudice the people of said barrio, because school children will have to go to either Punta or the City Central School which are both quite a distance from Barrio Alegria;

"WHEREAS, this Board has learned that the enrollment in said barrio warrants the opening of the school, and that according to the Barrio Lieutenant that people of the barrio had signified their willingness to shoulder the expenses for the rentals of a building or buildings to house the classrooms;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to request the Division Superintendent of Schools, Tacloban City, through the District Supervisor, Ormoc I, Ormoc City, to continue the classes in Alegria, Ormoc City, because of sufficient enrolment, said classes to be housed in private buildings to be rented by the PTA of Barrio Alegria;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Division Superintendent of Schools, Tacloban City; the District Supervisor, Ormoc I, Ormoc City; the Honorable City Mayor, the City Treasurer, the City Auditor and the Barrio Lieutenant of Alegria, all of Ormoc City.
