RESOLUTION NO. 111

"WHEREAS, during the widening of city streets the city government used up a portion of Lot No. 511 of the Ormoc Cadastre, along C. Aviles and Bonifacio Streets, containing an area of 19.588 square meters;

"WHEREAS, Mr. Basilio P. Codilla, attorney-in-fact designated by the owners of the portion affected by the widening of Bonifacio Street, made representations with this Board, requesting payment of of said portion used by the city government; and

"WHEREAS, this Board has seen that the claim is in order, considering the fact that a Road-Right-of-Way Agreement has been duly accomplished and executed by the landowner and the city government represented by the City Mayor;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of P489.70 from out of the Roads and Bridge Fund, to be made available for the payment of the Road Right-of-Way claim of Mr. Basilio P. Codilla, hereby authorizing the City Treasurer to pay to said Mr. Basilio P. Codilla this amount upon presentation of a duly accomplished voucher;

"RESOLVED FINALLY, to furnish copies of this Resolution each to His Honor, the City Mayor, the City Treasurer, the City Auditor, the City Engineer and Mr. Basilio P. Codilla, all of Ormoc City.
