RESOLUTION NO.

Letter of the Division Superintendent of Schools, Tacloban City, addressed to this Body, dated June 18, 1957, quoted hereunder, follows:

> "BURKAU OF PUBLIC SCHOOLS VISION OF LEYTE

> > Tacloban City, June 18,1957

"The Honorable City Council Ormoc City

Gentlemen

"The undersigned repeatedly informed that Honorable Body that because of definite instruction he received from the Director of Public Schools not to authorize the opening of Ormoc City High School without hearing from him, it would be embarrassing for this Office to recommend the opening of said Ormoc City High School without any concrete information on hand as to how much has already been accomplished by the City of Ormoc toward the acquisition of an eight-hectare site for the Ormoc City High School. However, in view of the earnest appeal made by his Honor, City Mayor Esteban C. Conejos, and Honorable Jorge Tan Jr., Councilor of that Honorable Body, the undersigned would be willing to authorize the temporary opening of Ormoc City High School subject to the final approval of the Director of Public Schools if the following conditions are completely met:

The Honorable City Council of Ormoc passes a resolution definitely pledging the City of Ormoc to secure the eight-hectare site required by the Director before the end of this school year, 1957-1958. Should that Honorable Body fail to acquire the said school site within the school year 1957-58, that Honorable Body Body authorizes the Office of the Division Superintendent of Schools to transfer or lay off all the teachers of Ormoc City High School and close the said school.

(RESOLUTION NO. 112, SERIES 1957 - MUNICIPAL BOARD, ORMOC CITY)

"On the receipt of said resolution, this Office will wire immediately the City Supervisor who is in charge of Ormoc City High School to open temporarily Ormoc City High School.

"WHEREAS, in view of the desire of this Body to continue the operation of the Orroc City High School in order to afford high school students in Orroc City and the neighboring towns public high school aducation;

"NOW, THEREFORE, the Roard, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to definitely pleage as this lody through and by this Resolution hereby pleages, the acquisition of the eighthectare site required by the Director of Public Schools, before the end of this school year, 1957-1958;

"BE IT FIRMER RESOLVED, that should this Body fail to adquire the said school site within the school year 1957-1958, the Vivision Superintendent of Schools for Leyte is, as he is hereby, authorized to transfer or lay off all teachers of Ormoc City High School and close the said school;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Division Superintendent of Schools,
Pacloban City; the District Supervisor, Ormoc I, Ormoc
City; the Honorable City Mayor, the City Treasurer and
the City Auditor, all of Ormoc City.
"CARRIED."
