RESOLUTION NO. 112

"WHEREAS, Mr. Quirimon Tan, a former Sergeant of the City Police Force's Secret Service Division, presented a claim before this Board in two city vouchers covering salary difference while he was in the service as Sergeant of the Secret Service Division;

"WHEREAS, this Body believes that Mr. Tan is legally entitled to collect his claim, with the consideration that his appointment by virtue of which this salary difference has been accumulated is approved; and

"WHEREAS, according to the books of the accounting section of the office of the City Treasurer, there is, as of the present, a salary savings in the Police Department amounting to ₱269.15 which could be partly applied to this claim of Mr. Quirimon Tan;

"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to revert the amount of ₱269.15 from out of the salary savings of the Police Department and ₱28.41 from out of any funds not otherwise appropriated, to be made available for the payment of the salary difference of Mr. Quirimon Tan, hereby authorizing the City Treasurer, Ormoc City, to pay to said Mr. Tan his claim from the aforestated appropriations;



"CARRIED UNANIMOUSLY."




