RESOLUTION NO. 114

"WHEREAS, Councilor Parrilla informed this Board that in his conversation with Lt. Ricardo F. Viajar, Commanding Officer of the 59th PC Company at Ormoc City, he learned that there are two units of pre-fabricated school buildings presently dumped at wharf;

"WHEREAS, Councilor Parrilla also stated that according to Lt. Viajar the Municipal Mayor of Calubian, for which these two units of pre-fabricated school buildings have been allocated, is lukewarm to receive them; and

"WHEREAS, Ormoc City is badly in need of pre-fabricated school buildings to replace dilapidated bamboo school buildings in the barrios;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilors Alvaro I. Gutierrez and Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to request the Provincial Committee on Reallocation of pre-fabricated school buildings to allocate these two units of pre-fabs which are presently dumped at the Ormoc City wharf to the City of Ormoc, for the reason that on reliable information the Municipal Mayor of Calubian for which these two units have been intended, is lukewarm in receiving them, and that the City of Ormoc is in dire need of these pre-fabricated school buildings;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Provincial Commander, Tacloban City; His Excellency, the President of the Philippines, Malacañang, Manila; the Director of Public Schools, Manila; and the Division Superintendent of Schools, Tacloban City.

"CARRIED UNANIMOUSLY."
