RESOLUTION NO. 115

"WHEREAS, this Board passed Resolution No. 54, c.s., granting a franchise for telephone service in Ormoc City to the Ormoc City Telephone Co., Inc., subject to the approval of the Public Service Commission and the President of the Philippines;

"WHEREAS, as a requisite for the approval of the telephone service franchise, the applicant is made to submit to the Public Service Commission a Map of the territory to be supplied with telephone service, showing distribution layout and indicating location of central station and power plant and of poles, manholes, handholes, duct lines and trenches on or along city streets, duly approved by this Board; and

"WHEREAS, Mr. Narciso C. Alfaro, one of the incorporators of the Ormoc City Telephone Co., Inc., appeared before this Board with a map in blue print showing the details of layout and indicating the location of the central station and power plant, etc., as enumerated in paragraph 2 hereof, requesting that the same be approved by this Board before submitting the same to the Public Service Commission;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Jorge P. Tan, Jr.;

"BE IT RESOLVED, as it is hereby resolved, to approve as this Body through and by this Resolution hereby approves, the the Map or plan submitted by the Ormoc City Telephone Company, Inc., showing distribution layout and indicating location of central station and power plant and of poles, manholes, handholes, duct lines and trenches along the city streets;

"RESOLVED FINALLY, to furnish copies of this Resolution each to His Excellency, the President of the Philippines, Malacañang, Manila; the Public Service Commission, Manila; the Honorable City Mayor, the City Engineer, and Mr. Narciso C. Alfaro, all of Ormoc City.
