

BE IT RESOLVED, as it is hereby resolved, to request the Philippine Sugar Quota Administration and all other government agencies charged with the control and distribution or sale of domestic sugar to stop or to take means to stop the spiralling of the price of domestic sugar for the protection of the consuming public;


