RESOLUTION NO. 117

"WHEREAS, the provisions of Republic Act 840 fixed the salaries of department heads of cities in accordance with their classifications based on the income of such cities;

"WHEREAS, one of the department heads whose salary was fixed in said RA 840 is that of the Secretary to the City Board or Council;

"WHEREAS, Ormoc City is classed or classified as a 4th class city;

"WHEREAS, according to RA 840 the Secretary of the City Board or City Council in 4th class cities will receive P200 per month or P2,400 per annum;

"WHEREAS, the Secretary of the Municipal Board of Ormoc City, Mr. Ramon Bantasan, is presently receiving P190 since October 17, 1953; before said date he was receiving only P150 thus, accumulating to his credit a salary difference of about P500 to date;

"WHEREAS, Mr. Ramon Bantasan presented a claim before this Board requesting partial payment of his salary difference in the amount of P300;

"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserger, seconded by Vice Mayor Rafael M. Mejia;

"BE IT RESOLVED, as it is hereby resolved, to revert from out of the per diem savings of the Municipal Board, the amount of P300 to be made available for the payment (partial) of the salary difference of Mr. Ramon Bantasan, Secretary to the Municipal Board, hereby authorizing the City Treasurer, Ormoc City, to pay to said Mr. Ramon Bantasan the amount upon presentation of a duly accomplished voucher;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and Mr. Ramon Bantasan, all of Ormoc City.

"CARRIED UNANIMOUSLY."
