RESOLUTION NO. 126

"WHEREAS, Councilor Jorge P. Tan, Jr. informed this Board that he has been informed or advised by the Provincial Agriculturist that had Ormoc City an in charge or somebody to take care of the distribution of government fertilizers, a number of sacks would have been given to the farmers of Ormoc City;

"WHEREAS, Councilor Tan further manifested that in order to avail of this opportunity of receiving government fertilizers which are given free to the farmers, he be allowed to receive and distribute the same to desirable farmers;

"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Penserga;

"BE IT RESOLVED, as it is hereby resolved, to authorize Councilor Jorge P. Tan, Jr., this city, to take over the functions of an agriculturist pending the appointment of one by the City Mayor and for this purpose, hereby authorizing him further to receive for the farmers of Ormoc City any and all aid from other government entities in the form of fertilizers for distribution to deserving farmers;

"RESOLVED FURTHER, to request the Provincial Agriculturist, Tacloban, to deliver to Councilor Jorge P. Tan any aid which may be allocated to the farmers of Ormoc City;

"PASSED UNANIMOUSLY."
