RESOLUTION NO. 128

"WHEREAS, Mr. Panfilo V. Polido presented a claim to the City Treasurer, Ormoc City, for salary for services rendered as Janitor of Liloan Elementary School, Ormoc City, for the Months of May and June, 1951;

"WHEREAS, the City Treasurer, in an indorsement to this Board dated June 4, 1957, recommended that the claim of Mr. Polido amounting to P140.00 be included in the annual budget for 1957-58 under the city intermediate school fund as outstanding obligation; and

"WHEREAS, this Body is made to understand in a manifestation by Councilor Teotimo P. Ocubillo that the City Treasurer signified his willingness to pay the said claim provided the same is incorporated in the current annual budget;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Vice Mayor Rafael M. Mejia;

"BE IT RESOLVED, as it is hereby resolved, to incorporate in the annual budget for the fiscal year 1957-58 under the city intermediate school fund as outstanding obligation, the amount of P140.00 representing unpaid salaries of Mr. Panfilo Polido for the months of May and June, 1951 in his capacity as Janitor of Liloan Elementary School, and hereby authorizing the City Treasurer to pay the said amount to Mr. Panfilo Polido;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the City Mayor, the City Treasurer, the City Auditor and Mr. Panfilo Polido, all of Ormoc City.
