RESOLUTION NO. 131

"WHEREAS, the Presiding Officer of this Board, His Honor, the City Mayor, informed the members of this Board that the President promised him the possible release of the amount of P120,000 from his contingent funds for the construction of feeder roads in this city;

"WHEREAS, in view of the eagerness of this Board to avail of this promise of the President to the Mayor and due to exigencies of time to ask for funds to finance projects for the advancement of this city, this Body deems it wise and proper to send back the Mayor to Manila together with the Vice Mayor in order to follow the promised release of funds for feeder roads in Ormoc City, and in order to follow up important and official papers in Manila;

"NOW, THEREFORE, the Board, on motion of Councilor Marciano S. Du, seconded by Councilors Alvaro I. Gutierrez, Guillermo T. Parrilla and Jorge P. Tan, Jr.;

"BE IT RESOLVED, as it is hereby resolved, to authorize His Honor, the City Mayor and the Honorable Vice Mayor, to go to Manila to follow up official matters regarding Ormoc City, and for this matter, to allow them to collect a cash advance chargeable against the current appropriations for traveling expenses of the Office of the City Mayor in the amount of P300 for each of them, to finance their travel;

"RESOLVED FINALLY, to furnish copies of this Resolution each to His Honor, the City Mayor, the Honorable Vice Mayor, the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED UNANIMOUSLY."
