RESOLUTION NO. 132

"WHEREAS, the Honorable City Mayor manifested before this Board that in his inspection around the city he has noted that the city lacks garbage boxes along the city streets wherein refuse can be deposited;

"WHEREAS, this problem of the insufficiency of garbage boxes had also been brought out by the City Health Officer in a communication to this Body, with the request that the city provide or find ways and means to provide sufficient garbage boxes along the city streets ;

"WHEREAS, Councilor Du suggested that these garbage boxes can be secured from donations of big business establishments, charitable organizations and other civic spirited citizens;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to request the City Mayor together with two members of this Board at his choice, to solicit donations of garbage boxes from the Ormoc Sugar Company, the Chinese Chamber of Commerce, the Milagrosa Transportation, the Leyte Autobus, the West Leyte Transportation Co., Inc., the San Miguel Brewery, the Lions Club, the Knights of Columbus, and other business establishments and civic spirited citizens in the city;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor and the City Health Officer, all of Ormoc City.

"CARRIED UNANIMOUSLY."
