Rafael D. Omega, who at the time of his death was Acting City Treasurer of Ormoc City, covered as follows:

P300.00 for the burial expenses; and 405.00 corresponding to three months balance of his salary at P135 (the rest of his three months pay payable by the Bureau of Customs)

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable Secretary of Finance, Manila; the Commissioner of Customs, Manila; the Honorable City Mayor, the City Treasurer, the City Auditor and Mrs. Maximiana C. Omega, all of Ormoc City.
