RESOLUTION NO. 134

"WHEREAS, Mrs. Maximiana C. Omega filed a claim with this Board for benefits under the provisions of Section 699 of the Revised Administrative Code, in view of the death of her husband, the late RAFAEL D. OMEGA who, until his death, was Acting City Treasurer of Ormoc City;

"WHEREAS, during the deliberation of this matter the Board sought the opinion of the City Attorney who was then present in the session hall, as to the legality of the claim under the aforementioned law, wherein the City Attorney opined that the claim is legal, considering the fact that the late Atty. Omega was unexpectedly overtaken by death while in Manila on official business;

"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of P705.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the payment of benefits under the provisions of Section 699 of the Revised Administrative Code to the widow of the late Atty. Rafael D. Omega, who at the time of his death was Acting City Treasurer of Ormoc City, covered as follows:

P300.00 for the burial expenses; and
405.00 corresponding to three months balance of his salary at P135 (the rest of his three months pay payable by the Bureau of Customs)



"CARRIED UNANIMOUSLY."


