RESOLUTION NO. 135

"WHEREAS, the Honorable City Mayor informed this Board that the last time he went to Manila His Excellency President Carlos P. Garcia promised him a part of his contingent fund to finance projects in Ormoc City;

"WHEREAS, the Honorable City Mayor is leaving today for Manila to follow up that promise of the President; and

"WHEREAS, the intermediate schools in Ormoc City is one department in the city which needs attention of the government such as the adjustment of salaries of intermediate teachers who are very much prejudiced because of the inability of the city to raise their salaries to the standards and the improvement of intermediate classes;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to request His Excellency, President Carlos P. Garcia, to include a part of his release for public works projects in Ormoc City from his contingent fund, an amount as an aid to the city intermediate schools of Ormoc City;

"BE IT FINALLY RESOLVED, to furnish copies of this Resolution each to His Excellency, President Carlos P. Garcia, Malacañang, Manila; and the Honorable City Mayor, Ormoc City.
