RESOLUTION NO. 137

"WHEREAS, Councilor Gutierrez brought to the attention of this
Board that the artesian well in barrio Punta suddenly stopped flowing;

"WHEREAS, Punta which is a community along the seashore and
abounded by nipa swamps, has no other means of water supply except
the said artesian well which suddenly stopped, so much so that at
present the fire department truck is being utilized to supply the
barrio people of Punta with water for drinking purposes;

"WHEREAS, Councilor Gutierrez further manifested that the
NWSA is willing to undertake the repair of said artesian well with
their equipment at the expense of the city; and

"WHEREAS, it is estimated that repairs of said artesian well
will cost about ₱500;

"NOW, THEREFORE, the Board, on motion of Councilor Alvaro I.
Gutierrez, seconded by Councilors Parrilla and Du;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the
amount of ₱500 from out of any funds existing in the city treasury
not otherwise appropriated, to be made available for the payment of
expenses for repairing the artesian well in barrio Punta;


"RESOLVED FINALLY, to furnish copies of this Resolution each
to Mr. Felipe Victoria, NWSA, Ormoc City; the Honorable City Mayor,
the City Treasurer, the City Auditor, the City Engineer and the
barrio lieutenant of Punta, all of Ormoc City.

"CARRIED UNANIMOUSLY."


