S i r s :

The clerical force of the Assessment Department
have complained of the intense heat from midday to af-
ternoon, in their office accommodations (Quonset Hut)
which they explained to be due to the radiation from the
GI roofing of the fire engine garage. They have there-
fore requested that a repartition be made of their office
space which the Office of the City Engineer has estima-
ted to cost some P250.00.

In the interest of the service, I have the honor,
therefore, to request that P250.00 be appropriated for
said partitioning of the office of the Assessment Depart-
ment to be taken from funds otherwise unappropriated.

Preferential attention hereto is earnestly requested.
