RESOLUTION NO. 146

A RESOLUTION APPROPRIATING THE ANOUNT OF ONE THOUSAND FIVE HUNDRED PESOS (P1,500.00) FROM THE CENTRAL FUND UNAPPROPRIATED BALANCE TO BE GIVEN AS AN AID TO THE ORMOC CITY PUERICULTURE CENTER AND MATERNITY HOUSE FOR THE FISCAL YEAR 1957-1958.

"WHEREAS, the Board of Directors of the Ormoc City Puericulture Center and Maternity House, in its meeting held July 16, 1957, passed Resolution No. 3 addressed to this Board requesting the City Government to give an aid to the Puericulture Center as the city's counterpart to the national aid which is usually given in proportion to the city government aid;

WHEREAS any amount given to the Puericulture Center will be utilized for the operation and maintenance of this charitable institution which is serving the general public;

"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Tan, Jr.;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of One Thousand Five Hundred Pesos (P1,500.00) from out of any funds existing in the city treasury not otherwise appropriated, to be made available as an aid of the city government to the Ormoc City Puericulture Center and Maternity House for the year 1957-58;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Hon. City Mayor, the City Treasurer, the City Auditor, the City Health Officer and the President, Puericulture Center, all of Ormoc City.

"CARRIED UNANIMOUSLY."
