RESOLUTION NO. 147 - *Amended by Res. no. 118 c.s.*

"WHEREAS, this Board in its special session held on May 22, 1957, passed Resolution No. 95 appropriating the sum of ₱665.00 for the payment of unpaid salaries of Mrs. Otilia F. Devaras as classroom teacher of the Ormoc City High School from June 18, 1956 to October 31, 1956 at the rate of ₱150.00 per month;

"WHEREAS, in spite of said Resolution No. 95 Mrs. Devaras was not able to collect her unpaid salaries because her papers to support her claim were then incomplete until the books of accounts of the city treasurer were closed for transactions for the fiscal year 1956-57;

"WHEREAS, Mrs. Devaras submitted to this Board her papers already complete with the request that Resolution No. 95 be renewed so that the appropriations carried therein will be applicable to the current fiscal year;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilors Du, Gutierrez, Samson and Jorge P. Tan, Jr.,;

"BE IT RESOLVED, as it is hereby resolved, to repass resolution No. 95, c.s., in the same spirit and purpose for which it was passed with the amendment that instead of the appropriations taken from tuition fees collected from the students of the Ormoc City High School, the same be taken from any funds existing in the city treasury not otherwise appropriated;

"RESOLVED FINALLY, to furnish copies of this Resolution each the Hon. City Mayor, the City Treasurer, the City Auditor and Mrs. Devaras, all of Ormoc City.

"CARRIED UNANIMOUSLY."
