RESOLUTION NO. 128

"WHEREAS, during the regular session of this Board on December 8, 1956, Resolution No. 205, s. 1956, was passed directing the City Treasurer, Ormoc City, not to pay any claim of the NWSA pending contemplated action of the city government of Ormoc regarding the administration and control of the NWSA over the Ormoc City Waterworks System;

"WHEREAS, because of said Resolution No. 205, s. 1956, the City Treasurer refused to take action on a voucher of the NWSA seeking payment of the 3% due the NWSA Central Office in Manila and the 5% due the District Office in Tacloban from the actual collection of the Ormoc City Waterworks System; and

"WHEREAS, this Body has seen that the city is obligated by law to pay the said 3% and 5% shares to the NWSA;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to repeal Resolution No. 205, s. 1956, hereby authorizing as this Body hereby authorizes, the City Treasurer of Ormoc to remit the corresponding shares due the NWSA from the collections of the Ormoc City Waterworks System;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the General Manager, National Waterworks and Sewerage Authority, Manila; the Waterworks District Engineer, NWSA, Tacloban City; the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer and the Waterworks Supervisor, all of Ormoc City.
