RESOLUTION NO. 149

"WHEREAS, Councilor Parrilla manifested before this Board that in his conversation with Waterworks Supervisor Nestor Penserga of Ormoc City, it was made clear to him that the water pressure of the Ormoc City Waterworks System is strong enough to be extended to the barrios of Cogon Combado and Alegria, all adjoining the city proper;

"WHEREAS, Councilor Parrilla also understood from Engineer Penserga that even with the extension of the waterworks system to said barrios the water supply in the city will not be disturbed or hampered;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to request the National Waterworks and Sewerage Authority, Manila, thru Engineer Penserga of the Ormoc City Waterworks System, to extend the waterworks system in Ormoc City to the barrios of Cogon Combado, Alegria, Punta, Linao, Naungan and to the extension of Bonifacio St.;



"CARRIED UNANIMOUSLY."


