## RESOLUTION NO. 152

"WHEREAS, the Chief Executive of the City of Ormo, his Honor, the City Mayor, is a member of the League of Provincial Governors and City Mayors representing the people of Oroc City to said league of chief executives of provinces and cities throughout the Philippines;

"WHEREAS, in the meeting of said lesque held in Marila on February 15, 157, a resolution was unanimously approved to establish a Secretoriat of the Lague in Manika in order to have a staff of person to follow up papers affecting local governments the killer at offices of the national government at Manila, and such other same cer as may be beneficial to the different cities and provinces;

"WHEREAS, the Honorable City Mayor has signified his willingness to have this amount charged to his discretionary fund;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilors Parrilla and Ocubillo;

"RESOLVED, as it is hereby resolved, to revert from out of the Distretionary Fund of the City Mayor, the sum of ONE THOUSAND FOUR HUNDRED FORTY PESOS (Pl,440.00) to be remitted to the League of Provincial Governors and City Mayors, Suite 302, Escolta Building, Manila, as the contribution of Ormoc City for the maintenance of the secretariat of the League of Provincial Governors and City Mayors, for the current fiscal year;

File No. 8.01) published in the GAO Journal of May, 1957, before this amount could be remitted to the League of Provincial Governors and City Mayors in Manila;
