RESOLUTION NO. 152

"WHEREAS, the Chief Executive of the City of Ormoc, His Honor, the City Mayor, is a member of the League of Provincial Governors and City Mayors representing the people of Ormoc City to said league of chief executives of provinces and cities throughout the Philippines;

"WHEREAS, in the meeting of said league held in Manila on February 15, 1957, a resolution was unanimously approved to establish a Secretariat of the League in Manila in order to have a staff of persons to follow up papers affecting local governments with the different offices of the national government at Manila, and such other services as may be beneficial to the different cities and provinces;

"WHEREAS, it was further agreed in said meeting of the League of Provincial Governors and City Mayors, that for the maintenance of the League Secretariat each city and province shall contribute ₱1,440.00 per annum payable from either the discretionary funds of Provincial Governors and City Mayors or from direct appropriations in the different provincial and city budgets;

"WHEREAS, the Chairman of the League of Provincial Governors and City Mayors had already written twice to the City Mayor of Ormoc, asking for the remittance of the contribution of this city towards the maintenance of the League Secretariat, amounting to ₱1,440.00 for the fiscal year 1957-58; and

"WHEREAS, the Honorable City Mayor has signified his willingness to have this amount charged to his discretionary fund;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilors Parrilla and Ocubillo;

"RESOLVED, as it is hereby resolved, to revert from out of the Discretionary Fund of the City Mayor, the sum of ONE THOUSAND FOUR HUNDRED FORTY PESOS (₱1,440.00) to be remitted to the League of Provincial Governors and City Mayors, Suite 302, Escolta Building, Manila, as the contribution of Ormoc City for the maintenance of the secretariat of the League of Provincial Governors and City Mayors, for the current fiscal year;



"RESOLVED FURTHER, to request His Excellency, the President of the Philippines, to approve this resolution-appropriation, as the approval of the same is a requisite in a 2nd indorsement dated April 15, 1957 of the General Auditing Office (G.A.O. File No. 8.01) published in the GAO Journal of May, 1957, before this amount could be remitted to the League of Provincial Governors and City Mayors in Manila;

"RESOLVED FINALLY, to forward the original of this resolution to His Excellency, the President of the Philippines for approval, and that copies be furnished the League of Provincial Governors and City Mayors, Suite 302 Escolta Building, Manila; Honorable Sergio Osmeña Jr., City Mayor, Cebu City; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.
