RESOLUTION NO. 156

"WHEREAS, one Mr. Firmo D. Garcia filed a claim with this Board for payment of his accumulated vacation and sick leave as City Janitor-watchman in the City Central School from September 1, 1950 to June 30, 1951;

"WHEREAS, in the series of indorsements relative to this claim this Board understood that Mr. Garcia's separation from the service was not due to any fault of his own but due to lack of funds;

"WHEREAS, when Mr. Garcia's position was abolished due to lack of funds he was accredited to 26 days vacation and sick leave at P70 per month which he was not able to collect for lack of funds at the time he was separated from the service;

"WHEREAS, this Board sees no reason why such a legal claim as this should be denied;

"NOW, THEREFORE, the Board on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Marciano S. Du;

"RESOLVED, as it is hereby resolved, to revert the amount of P58.07 from out of the per diem savings of the Municipal Board, to be made available for the payment of 26 days accumulated vacation and sick leave of Mr. Firmo D. Garcia, a former City Janitor-watchman at the City Central School, Ormoc City.

"RESOLVED FINALLY, to furnish copies of this Resolution each the Division Superintendent of Schools, Tacloban; the Honorable City Mayor, the City Treasurer, the City Auditor, the City Supervisor, District I, and Mr. Firmo D. Garcia, all of Ormoc City.
