RESOLUTION NO. 158

"WHEREAS, during a special session held on August 13, 1957 this Board passed Resolution No. 147 appropriating the amount of P665.00 from any funds existing in the city not otherwise appropriated, for payment of the unpaid salaries of Mrs. Otilia F. Devaras for services rendered as classroom teacher of the Ormoc City High School from June 18, 1956 to October 31, 1956 at the rate of P150 per month;

"WHEREAS, this Board was made to understand that the unappropriated balance carried on this years budget for the general fund from which the above appropriation has been charged, can not be expended without the prior approval of the said budget by the Secretary of Finance;

"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Teotimo P. Ocubillo;


"RESOLVED, as it is hereby resolved, to amend Resolution No. 147, current series, to read as follows:
