RESOLUTION NO. 152

"WHEREAS, Precinct No. 31, Ormoc City, comprises the barrios
of Nasunogan, Sto. Niño, and the sitios of Bood and Candampigon;

"WHEREAS, the polling place of this said precinct is located in
barrio Salvacion, which is quite a distance from the above mentioned
barrios and sitios especially from barrios Nasunogan and Sto. Niño,
thereby causing too much inconvenience to the voters of said barrios
to go to Salvacion to cast their votes on election day;

"WHEREAS, this Board had noticed that in the past elections only
very few of the voters from barrios Nasunogan and Sto. Niño go to
Salvacion to cast their votes because these voters are idled by the
distance between these barrios and Salvacion especially during rainy
days, or when it rains on election day when the trail to Salvacion
becomes very muddy;

"WHEREAS, representations had been made by barrio people from
these barrios requesting that the polling place of their precinct be
transferred from its present seat in barrio Salvacion to barrio Nasu-
nogan in order to make it more convenient for the voters in these
barrios to go to the polling place and also to encourage new regis-
trants to register in the coming registration days;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla,
seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to request the Commission on
Elections to transfer the polling place of Precinct No. 31, Ormoc City,
from its present seat in barrio Salvacion to barrio Nasunogan for the
reason that the electors of barrios Nasunogan and Sto. Niño and the
surrounding sitios have been encountering inconvenience because of the
distance between these barrios and Salvacion;

"RESOLVED FURTHER, to request the Commission on Elections to al-
low the qualified voters of barrio Sto. Niño to register in Precinct
No. 28 in the barrio of Simangan for the reason that Simangan is the
nearest point to the place where they are residing;

"RESOLVED FURTHERMORE, to send this resolution to the Commission
on Elections immediately by wire;


"RESOLVED FINALLY, to furnish copies of this resolution each
