RESOLUTION NO. 161

"WHEREAS, the City Treasurer has received from the Philippine Charity Sweepstakes as share of Ormoc City, three checks, to wit: PC Checks Nos. 03016, P109.08, for the draw held on April 28, 1957; 03097, P50.76, for the draw held on May 8, 1957; 03177, P65.71, for the draw held on May 19, 1957;

"WHEREAS, as provided by law, these shares may be allotted by the Municipal Board for the maintenance of provincial, city, and municipal hospitals, and for other health, social welfare, and charitable work based upon the recommendation of the chief of the health department;

"WHEREAS, the City Health Officer, Ormoc City, in a 2nd indorsement dated August 26, 1957, has recommended that these three checks above mentioned be applied to the salary of the Dental Attendant of his office;

"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to appropriate the amount of P225.55, the aggregate total of the three checks above mentioned, to the salary of the Dental Attendant in the Office of the City Health Officer, Ormoc City;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and the City Health Officer, all of Ormoc City.

"CARRIED UNANIMOUSLY."


