RESOLUTION NO. 163

"WHEREAS, the City Engineer, this city, in his letter to this Board dated September 3, 1957, requested the approval of an extra work done by Mr. Antolin A. Jariol, contractor for the construction of additional market buildings, in installing eight coralex translucent sheets as skylights in building A of the present market building construction;

"WHEREAS, this Body has noted that in the old market building where there is no skylight, the interior part is dark even at day time;

"WHEREAS, the installation of said coralex translucent sheets in building A of the new market construction is deemed by this Body as most beneficial to the public;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Gutierrez;

Jariol, hereby authorizing the extra payment corresponding thereto at P48.00 per translucent sheet, minus the cost of the GI sheet #26 replaced by said translucent sheets;

"CARRIED UNANIMOUSLY."


