RESOLUTION NO. 165

"WHEREAS, the City Central School teachers, this city, in a petition filed before this Board, requested the construction of a six-room temporary school building to house intermediate classes of the City Central Community School;

"WHEREAS, when said petition was first presented to the Board, it was referred to the Board's Committee on Finance for study, comment and action; and

"WHEREAS, Councilor Parrilla, Chairman of the Board's Committee on Finance manifested that after a thorough study on the matter, the committee has decided to consider the request favorably, setting aside for the purpose, P1,000.00 from out of the City Mayor's commutable allowance;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Du and Tan, Jr.;


"RESOLVED, as it is hereby resolved, to divert the amount of P1,000.00 from out of the current appropriations for Commutable Allowance of the City Mayor, to be made available for the construction of a temporary six-room school building to house intermediate classes of the City Central Community School;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer, all of Ormoc City; the Division Superintendent of Schools, Tacloban City; and the City Supervisor, Ormoc City District I, Ormoc City.


