RESOLUTION NO. 166

"WHEREAS, the City Engineer, in a letter to this Board dated September 6, 1957, informed that the city is indebted to the Board of Liquidators in the amount of P10,870.24, representing payment of one Tractor TD-14, one truck-tractor and one trailer, for which the said Board is pressing collection;

"WHEREAS, in the same letter the City Engineer requested an information as to whether the city is now in a position to pay the said indebtedness to the Board of Liquidators, or if not, he be given authority to return these heavy equipments to the Board of Liquidators;

"WHEREAS, the city is interested to buy these equipments, but as of the present there is no source of fund from which the same can be paid;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to request the Board of Liquidators, Manila, to defer collection of the city's indebtedness in the amount of P10,870.24 representing payment of one Tractor TD-14, one Truck-Tractor and one Trailer, until the next fiscal year;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Board of Liquidators, Manila; the Honorable City Mayor, the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.
