"WHEREAS, time and again, the barrio lieutenant and the intermediate classroom teachers of Sabang Bao have requested the amount of P120 with which to repair the said intermediate school building;

"RESOLVED, as it is hereby resolved, to revert the amount of P120 from out of the per diem savings of the Municipal Board to be made available for the repairs of the intermediate school building of barrio Sabang Bao, Ormoc City;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer, the Barrio Lieutenant of Sabang Bao and the Principal, Sabang Bao Elementary School, all of Ormoc City.
