RESOLUTION NO. 170

"WHEREAS, it has been the policy of this Board to furnish  
street lights to poorly lighted sections of city streets;

"WHEREAS, this Body has noted that the market entrance along  
Lopez Jaena St. and along Real St. (the entrance near Regner's  
store) have no lights; also that portion of Real St. near Aber-  
rilla's tailoring is also poorly lighted, and that portion of  
Lopez Jaena St. in between Wm. Bryan and Bonifacio St.;

"NOW, THEREFORE, the Board, on motion of Councilor Penserga,  
seconded by Councilor Du;


"RESOLVED, as it is hereby resolved, to request the City Mayor  
to cause the installation of electric light bulbs (25-watts each)  
in the following street sections of this city:

one at the market entrance along Lopez Jaena St. near  
Mr. Jaime Omega's store;  
one at the market entrance along Real St. near Mr. Reg-  
ner's store;  
one at Real St. near Aberrilla's Tailoring; and  
one along Lopez Jaena St. in between Wm. Bryan and  
Bonifacio St.;


"RESOLVED FINALLY, to furnish copies of this Resolution each  
to the Honorable City Mayor, the City Treasurer, the City Auditor  
and the Electric Lights Inspector, all of Ormoc City.
