## RESOLUTION NO. 172

"WHEREAS, Councilor Penserga manif stet that the people in the Sitios of Picas, Tabogocon, Landing and Kinakhangan, all of barrio Liloan, this city, had requested him to cause to be firmished or distributed to these sicios, pipes, 2-inch diameter, in order to carry water from a certain source to these sitios;

"WHEREAS, Councilor Penserga manifested further, that inasmuch as this matter consumns the Nakasa, a government entity whose job is all about waterworks, it would be proper for this Board to request the NWSA to furnish the necessary pipes to the above mentioned sitios;

"NOW, THERETONE, the Board, on motion of Councilor Penserga, seconded by Councilor Gutierrez;

REPOLVED, as it is hereby resolved, to request the NWSA at Ormor City, to Jurnish 40 pipes, 2 inches in diameter, for distribution to Sitios Nices, Tabogocon, Landing and Kinawhangan, all of barrio Liloan, thic city;

"RESOLVED FURTHER, to inform the NWSA, Ormoc City, that the parrio people of the places already enumerated, have manifested their willingness to supply the labor in laying these pipes free or voluntary;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable City Mayor, the Waterworks Supervisor, Ormoc City Waterworks System, and the City Engineer, all of Ormoc City. "CARRIED UNANIMOUSLY."
