RESOLUTION NO. 173

Amended by Res. no. 174 C.S.

"WHEREAS, during the widening of city streets the city government used up the whole of Lot No. 599 covered by TCT No. 112 in the name of Messers Teotimo S. Galenzoga and Daniel S. Galenzoga, located at Corner Real and Osmeña Sts. to widen Osmeña St.;

"WHEREAS, the owners of the lot above mentioned have made representations with this Board requesting that said lot be paid;

"WHEREAS, considering that this is an outstanding obligation of the city, and the fact that the said lot had been utilized by the government for many years now, this Board sees that the claim of the lot owners above-named is in order;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to appropriate the amount of FIVE HUNDRED FIFTY-FIVE PESOS (P555.00) from out of the current appropriations for the Roads and Bridge Fund, to be made available for the payment of the Road Right-of-Way claim of Messers Teotimo S. Galenzoga and Daniel S. Galenzoga, owners of Lot No. 599 which was used up by the city government to widen Osmeña St.;



"CARRIED UNANIMOUSLY."


