RESOLUTION NO. 175

A RESOLUTION AMENDING RESOLUTION NO. 173, CURRENT SERIES,
SO AS TO CHANGE THE CHARGES OF THE APPROPRIATIONS MADE
THEREIN FROM THE ROADS AND BRIDGES FUND TO THE SALARY
SAVINGS FROM ANY DEPARTMENT OF THE CITY GOVERNMENT PAID
FROM THE GENERAL FUND.

"WHEREAS, this Board passed Resolution No. 173 in its regu-
lar session held on September 13, 1957, appropriating the amount
of P555.00 from out of the Roads and Bridges Fund for the payment
of the Road Right-of-Way claim of Messers Teotimo S. Galenzoga and
Daniel S. Galenzoga;

"WHEREAS, the City Engineer and the City Treasurer, upon re-
ceipt of a copy of said Resolution No. 173 manifested their ob-
jections to the appropriations made therein in a series of indorse-
ments relative thereto, and recommended that instead of paying the
road right-of-way claim of Messers Teotimo S. Galenzoga and Daniel
S. Galenzoga from the Roads and Bridges Fund, the same be paid
from the city general fund;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla,
seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to amend Resolution No.
173, current series, so that the appropriations made therein be
charged against the salary savings from any department of the city
government paid from the general fund, instead of from the Roads
and Bridge Fund;

"RESOLVED FINALLY, to furnish copies of this Resolution each
to the Honorable City Mayor, the City Treasurer, the City Auditor
and the City Engineer, all of Ormoc City.

"CARRIED UNANIMOUSLY."
