RESOLUTION NO. 176

"WHEREAS, Councilor Du manifested before the Body that the people of barrios Alegria, Batuan and Punta, this city, thru their respective barrio lieutenants, have expressed their fear that in the months to come their houses and the lots on which their houses are erected might be washed away or eaten up by sea action if nothing is done to prevent further erosion of the foreshore land in those places;

"WHEREAS, according to the City Engineer the best remedy to the situation is the putting up of a rock pile or a sea wall, which is a big project requiring thousands of pesos to finance; and

"WHEREAS, the present finances of the city can not afford to allot such a big sum as the construction of a sea wall;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilors Parrilla and Gutierrez;


"RESOLVED, as it is hereby resolved, to request His Excellency, President Carlos P. Garcia, to give an aid of P20,000 from out of his contingent fund, for the construction of a sea wall along the shore of barrios Alegria, Punta and Batuan, Ormoc City, in order to protect houses of people living in these places, from the action of the waves;

"RESOLVED FURTHER, to inform His Excellency, President Carlos P. Garcia, that the erosion in these places due to sea action has been aggravated by the previous typhoons which lashed Ormoc City and which caused damage and rendered people in these places homeless;


"RESOLVED FINALLY, to furnish copies of this resolution each to His Excellency, President Carlos P. Garcia, Malacañang, Manila; the Honorable Secretary of Public Works and Communications, Manila; the Director of Public Works, Manila; the City Engineer, the Honorable City Mayor and the barrio Lieutenants of barrios Alegria, Batuan and Punta, all of Ormoc City.


