RESOLUTION NO. 179

"WHEREAS, the National Bureau of Investigation Academy Superinten-
dent in Manila, in a letter dated September 7, 1957, informed the Hon-
orable City Mayor that the NBI Academy will open its 5th class for Pol-
ice Officers on November 18, 1957;

"WHEREAS, it was made clear in the same letter that Ormoc City, as
a government agency, is entitled to send two candidates to the NBI
Academy, each candidate to be between 25 and 35 years old, physically
and morally fit, and with 30 units of college work, and to be nominated
by the City Mayor;

"WHEREAS, the same letter further states that the Academy offers
everything without charge except the estimated amount of P50.00 for
each student for materials and equipment that each might use for the
whole course, and except also the expenses incidental to school attend-
ance, such as transportation, lodgings and meals, expenses in extra-
curricular activities, and expenses incident to the graduation which
are left to the individual student to take care;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded
by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to authorize the City Mayor,
Ormoc City, to send two members of the police force to attend the NBI
Academy in Manila, policemen who are civil service eligibles besides
meeting the requirements mentioned in the second paragraph hereof;

"RESOLVED FURTHER, that the nominees to the NBI school provide
for their own expenses enumerated in the third paragraph hereof, except
the P50.00 for each student for materials and equipment which the city
will pay;

"RESOLVED FINALLY, to furnish copies of this resolution each to
the Honorable City Mayor, the City Treasurer, the City Auditor and the
Chief of Police, all of Ormoc City.

"CARRIED UNANIMOUSLY."
