RESOLUTION NO. 130

"WHEREAS, the people of barrio Linao, this City, thru the Head Teacher of Linao Community School, have requested this Board for an aid to enable them to construct a home economics building for Linao;

"WHEREAS, the letter which the Head Teacher of Linao Community School forwarded to this Board thru the City Mayor, stated that despite their efforts to raise fund for the construction of said home economics building, their resources netted them an amount enough for the posts only; and

"WHEREAS, the Municipal Board, taking into consideration that Linao is a barrio with complete primary and elementary grades without even a decent school building deserves at least to have a home economics building for the intermediate grades;

NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to appropriate the amount of P700.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available as an aid from the city government to the Linao Community School for the construction of a home economics building thereat;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Division Superintendent of Schools, Tacloban City; the District Supervisor, District I, Ormoc City; the Principal, Linao Elementary School, the City Mayor, the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.
