RESOLUTION NO. 181

"WHEREAS, it has been the policy of this Board to furnish lights to poorly lighted sections of the city and suburbs where there are several houses established;

"WHEREAS, this Body has noted that a community has been established along the banks of the Atilao River near Alegria, said community known as "Badlas";

"WHEREAS, this Body has noted further that there are electric posts planted in this community but that there are no lights on these posts to illuminate the community; and

"WHEREAS, the barrio lieutenant has also requested that a 25- watt bulb be installed on a post near the sea shore of Alegria right behind the house of Mr. Catangub;

"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to request the Honorable City Mayor, Ormoc City, to cause the installation of additional lights in the places aforementioned, that is, two bulbs in Badlas, Alegria;; one bulb along the sea shore of Alegria, behind the house of Mr. Catangub; and one in Alegria proper, the points at which these lights are to be installed will be directed by the barrio lieutenant of Alegria;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, and the Electric Lights Inspector, all of Ormoc City.

"CARRIED UNANIMOUSLY."


