RESOLUTION NO. 182

Amended by Res. No. 212 C.S.

"WHEREAS, in the city budget of Ormoc City for the fiscal year 1956-1957, there are incorporated fourteen classroom teachers for Ormoc City High School, two of these positions new for said fiscal year;

"WHEREAS, one of these two new positions was filled in by Miss Conchita A. Go from June 20, 1956 to November 3, 1956, having rendered services for this entire period;

"WHEREAS, from the date of its submittal to the Department of Finance for approval, said budget for the fiscal year 1956-57 has not been approved until this date; and

"WHEREAS, because of this non-approval of said budget Miss Go had not been paid of her salary for her services rendered during the period mentioned in the second paragraph above; and

"WHEREAS, considering that this is an obligation of the city government which is rightfully due Miss Go;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to revert from out of the current appropriations for the purchase of a school site for the Ormoc City High School (under the Ormoc City High School Fund in the budget), the amount of ₱617.50 to be made available for the payment of salary of Miss Conchita A. Go from June 20, 1956 to November 3, 1956, as classroom teacher of said school;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Division Superintendent of Schools, Tacloban City; the Principal, Ormoc City High School; His Honor, the City Mayor, the City Treasurer, the City Auditor and Miss Conchita A. Go, all of Ormoc City.

"CARRIED UNANIMOUSLY."
